This agreement is made on the 2nd day of November, 2016

Terms of Agreement

This agreement is made between the Babe Ke Ayurvedic Medical College & Hospital, Moga of Punjab State, India (hereinafter referred to as BABE KE and The European Institute for Scientific Research in Ayurveda (hereinafter referred to as EISRA).

Overview

Babe Ke Ayurvedic Medical College & Hospital, Moga, Punjab, India and The European Institute for Scientific Research in Ayurveda, having affirmed their common commitment to the values of intellectual freedom, educational excellence, and international cooperation, and having recognized the benefits which may be realized through expanded communication on educational in Ayurveda, the sharing of Educational and medical resources in higher education, research, and cultural exchange do hereby enter into this memorandum of understanding.

Therefore, in pursuit of common interests and joint endeavors between our two institutions, and in the service of the scholarly and professional development of each organization, the leadership of these two institutions agree to explore these goals and to examine all possibilities for enhancing educational and research cooperation for our students, staff, and faculty at our respective establishments for the duration of this agreement.

BABE KE and The European Institute for Scientific Research in Ayurveda have established a Partnership to advance the study of Ayurveda. We propose to cooperate in developing relationships with academic and practitioner Ayurveda organizations internationally, work together in Europe, keep each other informed about our projects, and undertake other projects. We also want to work together in administering BABE KE - The European Institute for Scientific Research in Ayurveda Agreement, as explained below-

Responsibilities of European Institute for Scientific Research in Ayurveda-

1. Marketing of the Courses in Singapore and other countries and to have a minimum number of students (to be mutually agreed upon)
2. Organizing & providing logistics for delivery of theory and practical classes for the students
3. Coordinating, and seeking funding for various inter-professional activities, e.g., visiting scholars, exchange of delegations, workshop presentations, on-line conferences etc.
4. Maintain lines of communication between participants, as well as with selected organizations such as publishers, to facilitate other professional activities;
5. Developing and/or translating publications, and disseminating relevant professional materials among participants;

Responsibilities of the Babe Ke Ayurvedic Medical College & Hospital-

1. Coordinate closely all academic matters relating to the program with European Institute for Scientific Research in Ayurveda.
2. Responsible for setting examinations and ensuring that the standards of the program are in accordance with the Institute's requirements
3. To deliver lectures/workshop in AYUSH stream as & when sought & funded by the European Institute for Scientific Research in Ayurveda

Examination and Issuing of Certificate: Euro 100/- per certificate to be paid by the European Institute for Scientific Research in Ayurveda to BABE KE.

Babe Ke is to issue certificate signed by the Principal and with the institute logo and rubber stamp with date. The certificate will be the control point for all the transaction.

Once or twice a year, a faculty (Ayurveda qualification, PG Level) from Babe Ke will be sent to invigilate the examination, check all papers and conduct classes / workshops during

their stay in The Netherland. The European Institute for Scientific Research in Ayurveda will bear the cost of accommodation and air ticket, visa & meals during the stay. The faculty are not to work, provide consultancy or to engage in the activities against the spirit of law & professional ethics. The faculty had to take full instructions from The European Institute for Scientific Research in Ayurveda or its associate partners.

Intellectual Property Rights

BABE KE and The European Institute for Scientific Research in Ayurveda shall retain the proprietary rights of the courses/programs.

Dissolution

The Agreement shall be dissolved upon the happening of any of the following events:

1. The adjudication of bankruptcy or insolvency of either of the parties.
2. The sale or other disposition, not including an exchange of all, or substantially all, of the Collaboration Agreement assets
3. Mutual agreement by the parties

This agreement would require an exclusive rights three years commitment by all Partners, and would be reviewed annually by the partners.
